



**Minutes of the Planning and Highways Committee Meeting  
held on Monday 13 February 2017 at 7.30 pm  
in the Fair Oak Village Hall**

**PUBLIC SESSION**

3 members of the public were present.

A resident complained about the state of the roads in the village, particularly Mortimers Lane which was covered in mud. He understood that the developers were sweeping the road, but this still left debris on the surface, drains and gutters. The Clerk was asked to write to the developer to advise that we would be asking the Enforcement Officer to halt the development unless satisfactory road cleaning was in place.

The agent and owner of the Mazels spoke in support of the outline application for the development of up to four dwellings and answered Members questions.

## **59 BUS SHELTER OUTSIDE THE CRICKETERS**

Members discussed Mr Scott's report from a recent BIFOHH team meeting suggesting of a bus shelter outside the Cricketers in Fair Oak Road. It was felt that this could over clutter the square with street furniture.

## **60 PEDESTRIAN CROSSINGS**

Mr Harwood lead a discussion for the need of two pedestrian crossings in Fair Oak. One at Winchester Road and the second in Sandy Lane. These to be added to the CIP list.

## **61 COMMUNITY INVESTMENT PROGRAMME PRIORITIES**

Members discussed CIP priorities. The list was outdated and the Clerk was asked to include last year's list. In addition:

- Village hall extension to include a dance studio – higher priority.
- Pedestrian crossings as listed above.

- Defibrillator at Sandy Lane telephone box.
- Circular path and new entrance at Oak Walk.
