Jacob Goodenough, from WYG, and the developer were present to outline plans and answer any questions on the proposed hybrid application at land east of Knowle Lane.

A local consultation had been carried out in surrounding rounds, which included Bradshaw Close, Mortimers Lane and Mimosa Drive, showing 29 letters of support and two against the proposals.
